Purpose

Burlington City Arts' Community Fund will provide general operating support grants of up to \$5,000 for Burlington-based small arts organizations to create or advance projects that engage and benefit Burlington's community.

As many relief funding sources come to an end, many arts organizations still struggle with post-pandemic challenges such as inflation, difficulty rehiring, and a shift in audience behaviors that require revising programs. Funds will be used to directly support Burlington's arts organizations with funding to fulfill their mission, support artists, create new work, and further the local economic impact of arts spending.

The program's goals are to:

- Support Burlington artists and arts organization fulfill their mission
- Engage Burlington residents in a creative process or increase access to arts experiences for Burlington residents
- •Support organizations that are actively working to expand participation from constituents of many different backgrounds, ages and identities

Eligibility

In an effort to increase arts resources within the following Burlington communities, BCA strongly encourages organizations with a commitment to diversity, equity, and inclusion to apply. Specifically, BCA encourage applications from arts organizations with a focus on serving people of color, LGBTQ individuals, individuals with disabilities, veterans, immigrants, and low-income communities. BCA believes that diverse perspectives and experiences are essential to a vibrant and thriving arts community and is committed to promoting equitable access to funding opportunities.

Additionally, to be eligible to apply, applicant organizations must:

- Be a registered entity with the State of Vermont
- Be an arts organization with a primary mission to create art, produce art, present art, or support arts and culture services for the public
- Have an operating budget of \$300,000 or less
- Be located in Burlington, serve at least 51% of audience members who are residents of Burlington, or present at least 51% of programming in Burlington.
- Be able to submit a W-9 form with an EIN #
- Work in any of the following disciplines: Visual Arts, Music, Dance, Theater, Performance Art, Literary Arts, Design (includes fashion, industrial, graphic, theater, architecture, etc.), curatorial projects, media arts/film, or transdisciplinary

The following are **not eligible** to apply to the Burlington City Arts Community Fund (Organization):

- Religious institutions
- Social service or educational organizations
- Public or governmental agencies
- Schools, school districts, and universities/higher education institutions
- Athletic teams, social organizations, fraternal organizations
- Regular staff and board members of Burlington City Arts
- Current year Burlington City Arts Community Fund panelists
- Individual youth under the age of 18 (although youth organizations with a primary mission in the arts ARE eligible to apply)
- Students enrolled in a degree program
- Past Community Fund recipients who have failed to complete a project or are delinquent in submitting a final report
